- 5. Chairman, IQAC shared his invaluable suggestions, emphasizing the approach the college should take in going for its first accreditation. He said that this evaluation exercise should be taken as an opportunity to place the college in the global arena.
- 6. Mr.L.Naveen Prasad, Vice-Chairman, New Prince Shri Bhavani Group of Institutions implored the college to become visionary in this fast-changing world of digital technology. Already multiple sources of information are available to students (eg. On-line courses) and in times

to come, classroom teaching will not be the leading but one of the many ways of gaining education. He emphasized that the college must broaden itshorizons to be able to compete with other global colleges and should be able to offeroverseas validated courses so that a student can complete her degree partly here and partly abroad.

Mr.P.C.Praveen Kumar, CEO, App Star Global, Chennai, Industrial expert member said that there should have a strong network of our alumni who can contribute hugely in presenting an impressive face of the institution. He agreed that limitations of following the AnnaUniversity curriculum are there but innovative methods can be employed in the execution of the curriculum.
